In fact, in Fiscal Year 2021, WSSC Water spent more than 33 percent of our payments with diverse businesses - our largest spend in recent history. Additional key accomplishments from our Minority Business Enterprise (MBE) and Small Local Business Enterprise (SLBE) Programs in Fiscal Year 2021 include:

- Awarding 29 percent of our contracts (\$136 million) to diverse businesses an 8 percent increase from Fiscal Year 2020;
- **Exceeding** our Aspirational Goals for MBE Payments and Awards in Architecture & Engineering, Construction Services and Professional Services; and
- Spending \$45 million with WSSC Water-approved SLBE firms a 3 percent increase from Fiscal Year 2020.

Please read more about our accomplishments in our Office of Supplier Diversity and Inclusion Performance Report. While we've made great progress increasing the use of diverse firms, there is more work to do... a lot more work! Over the next six years (Fiscal Years 2023 – 2028), we plan to spend \$4.25 billion to protect public health by upgrading aging pipes, plants and pumps across both counties to ensure safe, clean drinking water continues to flow to homes and businesses.

Since 1978, the office has administered WSSC Water's Minority Business Enterprise (MBE) Program (race and gender conscious) with the addition of the Small Local Business Enterprise (SLBE) Program (race and gender neutral) in 2001. Both programs continue to respond to the urgent need to eliminate barriers to success in the public market place for Prime Contractors and Subcontractors. The MBE and SLBE Programs reflect the commitment of the Commissioners, General Manager and Senior Leadership Team. This commitment reflects an understanding of the economic impact and level of job creation generated by the diverse businesses in the communities we serve. WSSC Water understands that when our diverse businesses experience growth in a fair and inclusive environment, our entire community benefits.

Fiscal Year 2021 Programs **Performance Results**

Minority Business Enterprise (MBE) Program

The continuation of the MBE Program at WSSC Water remains a critical component to remedying the effects of discrimination and eliminating barriers to contracting opportunities for diverse businesses. For more than 40 years, the MBE Program has sought to promote fair and inclusive contract participation, provide greater access for diverse firms, and produce educational content to further develop diverse businesses.

The Office of Supplier Diversity & Inclusion works diligently to increase the use of MBE and SLBE firms throughout WSSC Water. This combined approach has yielded the following key results for Fiscal Year 2021.

MBE Payments

- WSSC Water spent \$154 million (33%) with diverse businesses
- · WSSC Water met or exceeded its Aspirational Goals for payments to diverse firms in Architecture & Engineering, Construction Services and Professional Services
- WSSC Water spent 77% of its MBE payments with firms located in Maryland and Washington D.C.





MBE Awards

- WSSC Water awarded \$471 million in contracts, which included \$136 million (29%) in contract awards to diverse businesses
- WSSC Water exceeded its Aspirational Goals for contract awards to diverse firms in Architecture & Engineering, Construction Services and Professional Services
- WSSC Water awarded 58% of its MBE contract awards at the Prime contracting level

For the purpose of the FY 2021 Office of Supplier Diversity & Inclusion Performance Report, WSSC Water's contract payments and contract awards are based on the service areas of Prince George's and Montgomery Counties, other surrounding communities/counties in Maryland, Washington D.C. and out-of-state cities. Women Business Enterprise (WBE) firms are included in the MBE figures throughout this report, unless otherwise noted. The following pages provide an aggregate of the data for contract payments and contract awards for FY 2021.

MBE Contract Payments

The cornerstone of the MBE Program and a key performance measure is the dollar value of contract payments made to MBE firms. Actual contract payments to MBE firms measure the meaningful success of the MBE Program. The charts and graphs in the figures below provide a breakdown of MBE contract payments. All MBE payments reported for FY 2021 have been validated by MBE firms.

In FY 2021, WSSC Water's contract payments totaled \$474 million, while the MBE contract payments totaled \$154 million (33%), shown in Figure 3. WSSC Water's total contract payments are categorized into four (4) broad contracting areas: Architecture & Engineering, Construction Services, Goods & Services, and Professional Services. WSSC Water established MBE Aspirational Goals based upon the results of the 2015 Disparity Study.

In FY 2021, WSSC Water met or exceeded the Aspirational Goals for three out of four contracting areas — Architecture & Engineering, Construction Services, and Professional Services. Throughout the lifecycle of a contract, several variables influence the utilization of contractors, including change orders, contract scope changes, and the availability of the proposed project team.



A major initiative contributing to minority- and women-owned business inclusion during FY 2021 is our Sewer Rehabilitation, Replacement and Relocation program. This \$90 million program to rehabilitate WSSC Water sewers in Prince George's County and Montgomery County includes the lining and replacement of sewers and rehabilitation of sewer manholes. WSSC Water has more than 80 miles of sewer mains and more than 1,800 manholes in this program and work is expected to continue through March 2023.

Figure 4 shows that African-American firms received the largest share of MBE contract payments at 46%, followed by Hispanic-American and Asian-American firms at 24% and 19% respectively.

L.E. Blue & Associates, Inc. is an African-American owned firm and certified Minority Business Enterprise in Prince George's County, specializing in general contracting services, specifically constructing water and sewer mains.

L.E. Blue & Associates is working with WSSC Water on a number of contracts, including our Emergency Water and Sewer Main Repairs contract. This \$42 million contract addresses emergency and urgent water main and sewer main repair/replacement as a result of aging infrastructure in Prince George's and Montgomery County. Contractors are required to be available and provide services 24 hours, 7 days a week, including holidays.

Figure 5 shows that Maryland and Washington D.C. firms received 77% of WSSC Water's MBE payments in FY 2021. WSSC Water spent 22% with MBE firms in Prince George's County and 15% with firms in Montgomery County.




Figure 6: MBE Contract Payments, FY 2017 - FY 2021

Four requests for a full or partial waiver of the MBE/SLBE subcontracting goals were received in FY 2021. Of the four requests, two were approved and two were denied.

MBE Contract Awards

Contract awards serve as a leading indicator of future contract payments. Since contracts may have multi-year terms, the impact of contract award dollars on contract expenditures may extend beyond a single fiscal year.

WSSC Water awarded \$136 million (29%) in contracts to MBE firms as depicted in Figure 7 below. In FY 2021, WSSC Water exceeded the Aspirational Goals in three out of four contracting areas - Architectural & Engineering, Construction Services and Professional Services.

Of the \$136 million in MBE contract awards, nearly \$80 million (58%) was awarded to prime MBE firms and another \$56 million to MBE subcontractors.

Small Local Business Enterprise (SLBE) Program

WSSC Water's SLBE Program was created to provide race- and gender-neutral contracting opportunities for small businesses principally located in Prince George's and Montgomery Counties. The SLBE Program furthers WSSC Water's objective of fostering broad-based competition within the vendor community.

The programmatic benefits for participants include: contract-specific subcontracting goals and prime preferences. These benefits translate into economic growth for small businesses through increased payments and award of WSSC Water contracts.


Figure 10: FY 2021 SLBE **Contract Payments**


WSSC Water spent \$45 million with WSSC Water-Approved SLBE firms, as depicted in Figure 12, with more than \$28 million in the Construction Services contracting area.

Figure 13 shows that 49% of SLBE payments went to firms located in Prince George's County and another 23% to firms in Montgomery County. Firms are eligible for consideration in WSSC Water's SLBE Program if the firm's principal location is in Prince George's or Montgomery County, or if at least 25% of the firm's workforce resides in either county.

WSSC Water awarded \$24 million in contracts to WSSC Water-Approved SLBE firms in FY 2021, as depicted in Figure 14, with more than \$19 million in the Construction Services contracting area.

V. Fernandes Construction Co., Inc. is a WSSC Water-Approved SLBE firm located in Montgomery County, Maryland. V. Fernandes Construction Co. has been an integral partner on our Large Meter and Large Meter Vault Replacement program. This program includes replacement of aging large meters and brick vaults with new meters and precast concrete meter vaults, and the installation of water mains.

These large meters serve school sites, apartment complexes and commercial/industrial sites located throughout Prince George's and Montgomery County. Approximately 30-55 large meters are replaced through this program annually.

In Fiscal Year 2021, WSSC Water awarded our \$3.4 million Edgewood Water Main Replacement project to V. Fernandes Construction Co., Inc. This project includes replacement of approximately 3,097 feet of 10-inch water main, installation of 55 fire hydrants and 248 water house connections to serve the Gaithersburg area of Montgomery County, Maryland.
